NEP -2020 was not implemented in our institution till 2023 hence the question of multidisciplinary/interdisciplinary studies is not relevant within the assessment period, that is between 2018-19 and 2022-23. The students will undergo courses in multi/interdisciplinary category to have basic knowledge not only in major areas but also in other disciplines broadly grouped under (Natural and Physical Sciences), (Mathematics, Statistics, Computer Science and Computer Applications), (Library, Information and Media Sciences), (Commerce and Management), and (Humanities & Social Sciences). Modality of selection of a subject for Multi/Inter Disciplinary Courses: A student shall

	have to study three (3) courses on a single subject in the field of Multi/Inter Disciplinary in 1st, 2nd & 3rd semesters.

5. Focus on Outcome based education (OBE):	Hiralal Bhakat College has only Undergraduate Programmes. These regular programmes are under the University of Burdwan. There are three streams. They are B.A., B.Sc. and B.Com. B.A. Programme has Honours and General Degree Courses simultaneously. B.Sc. Programme has only General Degree Course. B.Com. Programme has Honours and General Degrees as well as. In B.A. Programme Bengali, English, Sanskrit, History, Geography, Philosophy and Political Science are taught as Honours Degree Courses and General Degree Courses parallelly. On the other hand in B.A.

Programme Arabic, Urdu, Physical Education are taught as General Degree Courses only. In B.Sc. Programme Physics, Mathematics and Computer Science are taught only as General Degree Courses. In B.Com. Programme Accounting & Management are taught as Honours and General Degree Course both. Academic session 2018-'19 evidence only Part-III (Yearly System). Besides this, our assessment period (2028-'19 to 2022-'23) follows CBCS that is semester based. CCFUP (NEP) is followed from the academic session 2023-'24 to till date.

6. Distance education/online education:

The Hiralal Bhakat College is now an approved Post-Graduate Study Centre/Learner Support Centre (Code: S-05) of Netaji Subhas Open University (NSOU) starting from the Academic Year 2022-23. Renowned for its commitment to providing quality education, HB College is dedicated to offering comprehensive support to its students pursuing PG courses through open mode via its Study Centre. This initiative aims to facilitate their successful completion of courses and enhance their prospects for placement across various sectors, as well as participation in numerous research fellowship programs. Registration, renewal, examination form submission, and result publication are all managed centrally online by the University. However, the Study Centre is committed to providing robust academic support to ensure students successfully navigate their course requirements. It's worth noting that Netaji Subhas Open University (NSOU) stands as the premier State Open University in India, established under the State Act (W.B. Act (XIX) of 1997) and recognized by U.G.C. since August 20th, 1997. Presently, NSOU holds accreditation from NAAC with a grade of 'A'. The Hiralal Bhakat College has been approved as Post-Graduate study Centre/ Learner Support Centre (LSC Code: 63) of Rabindra Bharati Universitu (RBU) w.e.f. 11-03-2023. The HB College, having very good record of imparting quality education, aims at providing all-round supports to its students to complete the PG courses in open mode through its Study Centre/ Learner Support Centre, and thereby assist them to get placed in different sectors, and engaged in plethora of research fellowship programs. Registration, renewal, filling-up of examination form and publication of results etc. are centrally done

online by the University itself. However, the Study Centre will thrive to provide all academic support in completing the courses successfully. It is to be noted that The Rabindra Bharati University was established in 1962 to mark the birth centenary of the legendary poet Rabindranath Tagore, who was the first Indian as well as Asian recipient of the Nobel Prize for Literature. It is a State University named after Tagore dedicated to the mission of disseminating his thoughts and ideas through humanities, social sciences, art and culture. The Rabindra Bharati University thus features uniqueness in projecting itself as a centre for higher learning in performing arts, fine arts, language, literature and social sciences. There are three major faculties Arts, Fine Arts and Visual Arts, housed in the Emerald Bower Campus while the original campus Jorasanko, now houses a museum, and hosts a number of events like Tagore's birth and death anniversaries, or the annual University Convocation, to name just a few. 1.1 Curricular Planning and Implementation

1.1.1

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Hiralal Bhakat College, affiliated with Burdwan University, adheres to the curriculum prescribed by the University. The institution has established several mechanisms to ensure well-planned curriculum delivery and documentation, under the supervision of the Internal Quality Assurance Cell (IQAC).

The college prepares its own academic calendar, aligned with the University's calendar, before the academic session begins. This calendar is uploaded on the college website and displayed on departmental notice boards. The routine committee, along with the IQAC, prepares the session's timetable, which is distributed to department heads and displayed accordingly.

At the beginning of the session, the Principal and the IQAC Coordinator conduct meetings with departmental heads to strategize effective curriculum implementation. Departmental heads then meet with faculty members to allocate classes and syllabus. These plans are communicated to students once approved in departmental committee meetings. Teachers prepare Annual Lesson Plans based on the allotted syllabus and class routine, conducting classes accordingly. Student attendance records are maintained by respective departments.

Traditional teaching methods, primarily chalk-and-talk and lecture methods are predominantly used. However, some teachers enhance the learning experience with Information and Communication Technology (ICT). Faculty members supplement classroom teaching with special lectures, seminars, projects, field visits, industrial visits, and internships.

Continuous evaluation through class tests, midterm examinations, and internal assessments track student progress. Slow learners are identified and provided with remedial classes. Special care is taken by the IQAC to update the college website and notice boards regularly.

The central library, fully automated, boasts over 21,000 printed books, eight periodicals, and access to e-books and e-journals via the INFLIBNET NLIST platform. Throughout the academic session, various seminars and webinars are organized by different departments to address diverse issues.

At the session's start, under IQAC and Academic Subcommittee supervision, an academic calendar is prepared, following the affiliating University's calendar. Each department prepares a calendar of events, and the routine committee distributes the time table to department heads, reflecting it on the college website. The Principal, IQAC Coordinator, and Academic Subcommittee discuss curriculum implementation strategies, including internal assessments, evaluation processes, teaching-learning methods, and implementation of program and course outcomes.

Departmental heads prepare departmental routines based on the master routine, assigning curriculum portions to faculty, including full-time and SACT members. Teachers create teaching plans within the given timeframe and conduct classes accordingly, with extra classes scheduled to complete the syllabus on time. Teaching methods include both online and offline modes, supplemented with webinars, special and extension lectures, projects, online quizzes, poster/paper presentations, and publications of wall/e-magazines. Continuous evaluation, including online class tests, mock tests, and internal assessments, is conducted and preserved through various digital platforms.

Regular faculty meetings, coordinated by the Routine Sub-Committee, Internal Exam Committee, Academic Sub-Committee, and Teachers' Council, ensure alignment with program objectives and academic standards. Student feedback surveys, alumni career outcomes, and faculty performance reviews provide insights for improving standards and refining teaching methodologies, ensuring the curriculum remains relevant and dynamic to empower students for success.

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

Our institution, Hiralal Bhakat College is affiliated under The University of Burdwan and UGC. We follow all the rules and regulations of the universities in every aspect. CBCS mode has been implemented since 2017-18, from that academic year internal and external examination are conducted by the college as per guidelines of universities. From 2022-23 academic year we adopted NEP in our education system. 20% of each paper is evaluated by the internal examination whereas rest of the paper examined as external examination. CBCS and NEP system courses are divided into few semesters. A semester consists of six month. All the papers except SEC paper include 10 marks as assignment/class test/viva and 5 marks are given on students' attendance. In case of SEC paper 5 marks is given for class test/assignment/viva and remaining 5 marks on attendance.

From the very beginning of the semester, students are awarded about the total examination procedure. Tentative date of internal examination and external examination are mentioned in our academic calendar. There are academic and internal examination committees to decide various academic affairs like internal examination date by conducting meetings etc, throughout the year. We circulate examination related detailed notification to students through official Whatsapp group and college website. For transparency, our faculty members evaluate all the related papers and display to students and accordingly solve their discrepancies and mistakes. All the departments preserve examination related documents like question papers, answer scripts and upload the marks in the university portal as per university's notification. During Covid-19, all types of examination have been conducted through online mode.

We arrange parent's teacher meeting for discussing about students performance in internal assessment

and we take some extra care for low scoring students. We provide them extra/ remedial classes for preparing the semester end examination.

Semester end examination is arranged by the universities. We convey all examination notification to the students and distribute admit cards to them.

To keep transparent the examination mechanism, Hiralal Bhakat College has already taken some initiatives. If any grievance arises about the transparency of examinations, anyone can complaint to his/her respective departmental head. Department also takes it seriously and resolved the matters. Beside this, students may directly complaint to principal office. All quires and doubts regarding examination are resolved as soon as possible. After publication of result of end semester, there is a provision of review, if any student is not satisfied with his/her marks, then he/she can apply for review, college arrange all the procedure of review.

Principal, IQAC Coordinator, Examination committee, Academic committee, all play pivotal role in case of any discrepancy arise, they take an immediate action to resolve the discrepancy. In case of critical situation, we inform university and request to solve the matter.

Highest administrative body of our institution is the Governing Body. Then the Teachers' Council and Internal Quality Assurance Cell. Each and every policy and plan of college comes up through different Advisory and Sub-Committees. Basically, we follow a bottom-to-top approach. There are twelve Advisory Committees along with the Finance Sub-Committee which have participation of all the three wings of college, namely Teaching Staffs, Non-Teaching Staffs and Students. The Finance Sub-Committee, being a management-committee, is constituted following the Statute of the University of Burdwan and is having all its members elected or selected as members of the Governing Body. Each of these bodies has a convener, who is a Full-Time Teacher or Librarian (Library Advisory Committee) of college. The resolutions of these meetings are placed in Governing Body meetings and are usually passed with little additions and alterations. Committees like Teachers' Council (another Statutory Body), Grievance Redressal Cell, Anti-Ragging Cell, Gender Cell and Internal Complaint Committee have been formed following the guidelines of UGC, the University of Burdwan and the Directorate of Public Instructions, Government of West Bengal and have been functioning with apt concern and care.

The GB and IQAC get together on a regular basis to discuss how the programmes are being carried out. The IQAC is active because the standing Cell, which is made up of following the guidelines of UGC and is led by the IQAC Coordinator, conducts an assessment of the entire institution and works to inspire the Faculty and Students to achieve the goals while meeting their usual academic responsibilities.

- 9. Forming joint ventures with other respected institutions.

Strategic Plan deployed to improve Teaching and Learning:

- 1. Teaching and learning methodology includes paper presentations, quizzes, inquiry learning, hands on activities, case studies etc.
- 2. Each faculty mentor has a group of 15 to 20 students whose overall growth and development are continuously monitored by faculty and in most of the cases their problems are resolved.
- 3. Institute has a Wi-Fi enabled campus.
- 4. Library subscribes to volumes of journals, magazines and newspapers. The total number of them has increased to 36660 in 2020-21 from 23606 in 2016-17. Similarly the volume of e-books has increased to 11,620 in 2020-21 from 5331 in 2016-17 etc.
- 5. We switched to an online mode of education during COVID-19.
- 6. During COVID-19 Pandemic, Examination and evaluation were held as per the rules and regulations of the University of Burdwan and the institute strictly adhered to them.
- 1. The organizational structure of the College consists of the Governing Body, the Principal/ Teacher-in-charge, the teaching staff, the non-teaching staff and the students.

An effective performance management system plays a crucial role in managing the organization in an efficient manner.

Every year, teachers submit a self-evaluation form, which is available online.

The college's IQAC evaluates the faculty/department report that has been filed and conducts an academic audit, which is subsequently shared with the departments.

The performance appraisal is also used for Career Advancement of the teachers who are updated about their performance at each level.

The feedback forms are made available both offline (collage office) and online (college website) in accordance with the guidelines of IQAC and the respective HODs so that developments can be made sure of by confirmation of the process of filling and submission of the aforementioned forms by maximum number of students.

Feedback forms are then evaluated by the respective HODs and the Principal of the institution with the help of IQAC who analyses all the reports and meets with teachers with constructive feedback and corrective measures.

6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

Institution has taken an initiative of a systematic mechanism of utilization and mobilization of funds. College authority has already formed different types of statutory bodies like the Finance Sub-Committee, Purchase Sub-Committee which are directly linked with accounts and audit works. Funds are always required for maintaining regular activity and development of the college. The college received various types of funds like funds from students' fees collection, scholarships, NCC grant, RUSA 2.0 fund etc. Besides the grants received from Government organizations, our college also received grants from non-Government organizations such as our respective faculty Dr. Ranjit Kumar Sarkar donated Rs. 1,00,000/for the development of our institution in 2022-'23. In 2021-2022, Hariharpur Friends of Environment donated Rs. 41,000/- for educational infrastructure for the Department of Geography and Raja Rammohan Roy Library Foundation donated Rs. 50,000/- in 2022-'23 for organizing state and national level seminars. Fees collection from students is one of the main sources of funds for our college. Our college received RUSA grants of Rs. 2 crores for up gradation of existing Degree College into Model Degree College. College also collects funds from the MP Lads (Central Government). Sometimes various competitive examinations are held in our college campus and collect revenue for renting our campus. After receiving any kinds of grants, the college mobilizes those funds as per proper strategic planning.

The College has a separate account section, they maintain all the required books of account and prepare all relevant documents and keep the files safe. Most of the transactions occurred through demand draft or cheque and transactions with small amounts occurred through cash. Accounts and cash department of the college maintain the safety of all the documents and take required steps from time to time. For transparency of accounts, the college conducts internal audit as well as external audit every year as per the directions of Higher Education and Finance Department of West Bengal Government. At the end of every financial year, the authority prepares Income & Expenditure account, Receipts & Payments

account and Balance sheet. It is compulsory to conduct an audit to check whether the books of accounts show a true and fair view or not. The Finance Sub-Committee and Bursar supervise the books of accounts throughout the year.

Internal Audit: The College arranges internal audits of its books of accounts. A certified chartered accountant has been employed by DPI, Higher Education, Government of West Bengal. Auditor's report is placed before GB and submitted to the DPI within the stipulated time.

External Audit: Office of the Principal Accountant General (General & Social Sector Audit), West Bengal conducts the external audit of our college every year. Audits were conducted successfully without any hindrance by providing quick reply with proper documents on queries raised by the auditor. We take immediate action on the auditor's suggestion and accordingly, submit the audit report to DPI, Higher Education, Government of West Bengal in time.

6.5 Internal Quality Assurance System

6.5.1

Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes. It reviews teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals and records the incremental improvement in various activities

Response:

The institution has established an Internal Quality Assurance Cell (IQAC) for academic excellence. This cell is an activity engaged for smooth running of academic atmosphere including suggestions for infrastructural improvement, resource mobilization, giving emphasis on quality rather than quantity. IQAC sits and monitors the overall performances and also reviews the entire scenario of the institution. The Governing Body approves most of the recommendations of IQAC.

The IQAC has external members in its committee. They often recommend some good suggestions.

The ultimate effect of setting up the IQAC is the promotion of good academic atmosphere and to make an impact in the society. As per the recommendation of the IQAC, every effort is initiated to improve class teaching, interaction with the students, getting feedback, terminal examination, reviewing the result,

organizing seminar, group discussion, and debates and thereby enriching the quality education. Students often send their suggestions to IQAC through their feedback.

The institution has an integrated framework for quality assurance of academic and administrative activities.

IQAC achieves this through mainly two practices, viz.,

- 1. Conducting Academic Audits annually wherein departments are made to do a SWOC Analysis of their performance based on results, research projects, effective curriculum implementation and use of ICT-related pedagogical methodologies. Based on the audit, the IQAC gives constructive feedback to the Departments suggesting measures for internal quality enhancement. It makes recommendations for the Departments to do self-evaluation and to set higher goals to meet new challenges.
- 2. Collecting feedback from stakeholders like students, parents, staff and alumni to facilitate teaching-learning reforms. This helps in obtaining an unbiased and honest opinion about the institutional performance especially in academics. Student feedback of teachers is conducted regularly. A careful analysis of the feedback received is done and communicated to the teachers to enable them to enhance their teaching skills and their relationship with the students.

Attainment of Programme Outcomes, Programme Specific Outcomes and Course Outcomes IQAC suggests innovative pedagogical methodologies like PowerPoint Presentations, Projects, Field Trips, Workshops etc. in addition to the completion of curriculum through Assignments, Class Tests, Tutorials etc.

HBC is one of the few colleges that offer dedicated certificate add-on courses. These courses impart different skills and are transacted by practitioners, thus providing opportunity to students for hands-on experience and building bridges with the world of work.

Effective Use of ICT in Teaching and Learning

IQAC has ensured that all classrooms and labs are fully equipped with ICT facilities.

In the past five years, after accreditation (Ist Cycle), new laboratories have been constructed for two B.Sc (Bachelor of Science) Courses in (a) Mathematics, (b) Physics and (c) Computer Science.

An Audio-Visual Room has been set up to facilitate teachers to record their lectures.

Teachers are encouraged to use ICT tools to prepare and deliver their lectures through audios, videos and PPTs.

A Research and Collaboration Centre has been established in the Library to facilitate teachers to use the

ICT and e-resources for the purpose of doing research.

7.2.1

Describe two best practices successfully implemented by the Institution as per NAAC format provided in the Manual

Response:

Hiralal Bhakat College has taken so many good practices to achieve excellence in the field of higher education. They are described below:

Best Practice-I: Use of Academic ERP Software in Admission and Examination

Objective of the Practice:

- ? To provide a simpler and efficient system of governance within the institution through the implementation of academic ERP software in the admission and examination process.
- ? To make the admission and examination process transparent, time-saving and user-friendly.
- ? To follow the admission guidelines of the Department of Higher Education, Government of West Bengal and affiliating University.
- ? To cope up with the changing scenario in teaching-learning-evaluation process against the backdrop of the COVID-19 pandemic.

The Context:

Hiralal Bhakat College has earned a reputation of attracting learners for admission from the urban as well as rural areas. Currently, the institute offers 14 undergraduate programs (including 8 Honours). With a view of extending transparent, convenient, efficient and cost-effective services to the stakeholders, the

institution had introduced the student-friendly online admission process since 2017. After the outbreak of COVID-19 pandemic, all the HEI in the state have converted the admission process as well as examination process into online as per the order of the Govt. of West Bengal. The concept of academic ERP software in the academic admission and examination process, aims not only at achieving operational excellence in the institution, but also makes its stakeholders and beneficiaries of the system.

The Practice:

Cloud-based ERP Software was purchased from CMS (College Management Software). The college implemented academic ERP software in admission process through following procedures:-

- ? Conduct of Pre-admission process including online form fill up
- ? Generation of Merit List.
- ? Payment of Admission Fees
- ? Fees are tagged with each student automatically semester wise
- ? Payment of examination fees through online portal
- ? Taking final admission
- ? Generation of Student's Identity Card and Registration Data

The college implemented academic ERP software in Semester process for UG Program through the following ways:-

- ? Uploading of Subject wise Question Papers
- ? Uploading of Answer Scripts
- ? Registration card and admit card generation
- ? Downloading of the question papers by the students
- ? Online examination for students
- ? Answer Scripts Download by the institute for evaluation
- ? Result Sheet Generation and Submission of award list to the Burdwan University (BU)

Evidence of Success:

The complete admission process takes almost 10-20 minutes for each student. Payment for admission/examination fees through online takes only 5 minutes to conduct the total procedure. A confirmation mail in respect of admission/examination is generated and automatically sent to the student's email id.

Problems encountered and resources required:

The students coming from adjoining rural areas of college have faced problems in online admission and examination due to poor internet facility, lack of smart phone and computer facility. To overcome the obstacle, the institute extended help in the form of creating a good number of Helpdesks and making provisions for computer facility, wi-fi connection, counseling and assistance for admission and examination.

Best Practice-II: Introduction of New Innovative Skill Enhancement Initiatives & Community Development Programmes

Objectives of the practice:

- ? To develop interpersonal, behavioral and communication skills
- ? To teach the students effective soft skills & life-skill tools for capacity building and skill enhancement
- ? To enable students to comprehend the expectation of industry
- ? To bridge the skill gap between curricula- based and making them ready for industry jobs...

The Practices:

- ? A training camp was arranged by College between 14.10.2019 to 22.10.2019 with the help of Ram Shyam Fabric House (Pvt. Ltd.), Santiniketan, Birbhum to train 30 housewives of adjacent locality. The intricacies of tailoring activities which enabled them to be self employed and Mayurakshi Gramin Bank, Nalhati Birbhum was appealed to provide them loans for purchase of sewing machines.
- ? A regular drawing learning session was arranged in the 'Durga Mandir', near Atgram Primary School around 2 km. away from college campus. Bapi Ghosh, an alumnus member of Hiralal Bhakat College Alumni Association and a resident of Atgram along with 16 number of students and 4 number of teachers arranged these sessions on and from 18.01.2021 to 08.05.2021 (74 sessions to be specific). This session enabled the kids of Atgram (42 of them almost regularly attended the said session) to come out of the monotony of their school-less life that too within the structure of COVID-19 protocol (physical distancing).
- ? Education Caravan was arranged by IQAC during the month of July, 2022 for propagating the courses both curricular and professional to the surrounding locality. The Principal in accompaniment with a number of teaching and non-teaching staff of college visited the surrounding locality especially the feeder schools with a flex, a sound system and a canvassing video. Interpersonal communication with prospective students was arranged in each session of a couple of hours. There were 8 such sessions in total which finally resulted in a larger frame of visibility among prospective students. It influenced the admission process during July and August, 2022 in a positive way.

Evidence of Success:

? Some of the local women became self-sufficient from the training offered by the college

- ? An attempt was taken to reduce the rate of illiteracy among the adults adjacent to college.
- ? Students are empowered with the power of skill-based learning offered by college in a true sense.
- ? The college authority was really serious about its community development programs at the time of lockdown period also. The college tried to remove bottlenecks among the kids of adjacent villages by involving themselves in the Drawing classes.
- ? Students' feedback in various programs reflects the evidence of success though real-life success is yet to be ascertained.

7.3 Institutional Distinctiveness

7.3.1

Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

Upliftment of Socially Backward Section & Empowerment of Women through Various Policies, Schemes, Practices and Outreach Programmes:

By generating quality human resources through imparting higher education to rural people Hiralal Bhakat College has been consistently striving to extend assistance to the weaker sections of society including women and enable them to cope up with challenges they face in their daily lives. Similarly, the founder, Hiralal Bhakat also donated his land for the establishment of the college to impart education to the local and socially backward population. Since its establishment in 1986 in a rural setting, the institution has played a pivotal role in changing the socio-economic cartography of its immediate rural stakeholders. For the socio-economic development of the adjoining areas, the college has always put emphasis on female education and promotion of gender-equality and gender-sensitization. Since the

college is situated in a backward area, it is also committed to empower the marginalized people through education and outreach programs. The two distinct areas in which Hiralal Bhakat College has continued its uninterrupted services and assistance include: i. Promoting Gender Equity & ii. Local Community Development Programs

1. Promoting Gender Equity:-

- Peing located in a semi urban and surrounded by rural regions, Hiralal Bhakat College since its establishment has witnessed a gender disparity amongst its student's population. However, with the passage of time and its evolving vision and mission, the institution has strived to reduce the gender gap and related gender discriminatory practices, promoting education for all and women empowerment. Consequently, the college has witnessed an increase in the enrolment of the female students. The total number of enrolled female students in the assessment period is greater than the total number of enrolled male students. The college offers various scholarship schemes like Kanyashree, Aikyashree etc. to attract female students and encourage them to continue and pursue higher studies. Concession in tuition fees is also given to the students so that they do not have to drop out due to the financial crisis. Besides, regular awareness camps, programmes are conducted by the college, Departments & NSS/ NCC Units on 'Beti Padhao Beti Banchao', 'Camp against Child Marriage'. 'Literacy Drive', 'Mental Health & Hygiene', 'Evil of Witch-hunting and untouchability' etc.
- Professor, Department of Law, The University of Burdwan in accompaniment with a number of 5 former students of his practicing in different courts of law. The legal advices received by the said victims were immensely helpful and they repeatedly visited college even after having specific solutions to their problems.
- ? Every year, International Womens' Day is observed with passion and fervor through special lectures, webinars, poster presentations by the Women's Cell, Internal Complaints Committee and by other interested Departments.
- ? The college has a gender-friendly and safe campus with provision for 24 hrs' security staff and CCTV surveillance. A Ladies' Common room is dedicated only for the female students. Additionally, the college also has a Gym and Sports facility for all students, irrespective of their social identities. We have notable women alumni who have made significant achievements.
- 2. Local Community Development Programmes:-
- ? Collection of used but almost new garments from all interested stakeholders of college and

distribution among the people belonging to the economically challenged part of surrounding locality during both Eid and Puja. 71 members of college family denoted clothes and 221 inhabitants of the surrounding locality received them.

- ? The unique quality of our college is the model relationship that exists between the faculty and students. The college fosters a respectful, non-threatening learning environment.
- ? A project of spreading readership was taken up between 18.11.2019 and 30.11. 2019 with a group of 30 students (11 male and 19 female) of the age group of 12 to 14 years. Story Books were given to them during this period and the ways the stories are best to be approached are taught to them by the students of Semester V Hons. The intention of this project was to inculcate playful energy among them towards education and general readership.
- ? An Adult Literacy Drive was arranged by IQAC with the help of a number of 12 teachers to select 41 nos. of adult members of 3 adjacent villages of colleges: Atgram, Choto Podhra and Boro Podhra within the age group of 51 to 69 years of age between 21st February 2022 and 26th February 2022. Regular morning and evening classes were arranged in the 'Durga Mandir' of Atgram around 2 km away from the college campus. This venture became successful enough to enable these candidates to write letters to the Principal of college thanking him as well as the entire team for opening up the new vista of their lives.
- ? The college gets RUSA funds for various purposes. One of the problems of the college is shortage of sufficient land for the flourishing of its different wings.
